- Ensure processes and SAP knowledge is continuously enlarged and applied in order to fully leverage the value of the integrated SAP system and to achieve high level of service, cost efficiency, quality and compliance.
- Establishes, maintains and operationality implements integration and reconciliation activities between Global NTO Supply chain, Procurement and Finance guidelines.
- Monitoring, controlling and improving SC processes and by managing and steering new products within the portfolio of CPO's, mapping if global standard solution covers new product launch from a supply/S4 Hanna POV.
- Ensure that all OM, ICOM and CTC processes comply with all relevant regulations like Customs and Trade laws and regulations by supporting issuance, implementation and management of Standards and Policies covering commercial and non-commercial materials.
