The Oncology Translational Research (OTR) Department at Novartis Biomedical Research is a global, laboratory-based research group, supporting the development of novel therapeutics in the Novartis Biomedical Research Oncology Disease Area. Within OTR, the Oncology Pathology and Biomarkers (OPB) group uses tissue-based, cell-based and soluble protein assays to understand target epidemiology and biology, mechanisms of action of drugs, and response/resistance biomarkers, ranging from early stages of target identification through Phase 3 clinical trials.

Key responsibilities:

- Develop tissue-based biomarker assays, e.g., Immuno Histochemistry (IHC), In Situ Hybridization, and Fluorescent Immuno Histochemistry (FIHC) to advance Novartis
 oncology programs
- Support a range of modalities and disease indications within Oncology and opportunities will exist to expand their current skill set and take on additional experimental challenges, as appropriate
- Develop single plex and multiplex IHC and FIHC automated assays to support clinical trials with minimal guidance
- Interpret experimental data, generate hypotheses, provide data analysis and suggest next steps
- Conduct routine image analysis using established platforms like HALO

- · Serve as point of contact for project teams and researchers, both within and outside the organization
