 continuous improvement in process governance. Advising senior parties on complex issues related to
 business process governance.
- Drive, monitor, and continuously improve business processes related to portfolio system use identifying bottlenecks, inefficiencies, and areas of improvement, then implementing corrective actions to enhance process performance and efficiency.

- Collaborate with stakeholders including senior leaders, business process owners, subject matter experts, and IT teams, to gather requirements, understand business needs, and ensure seamless integration of portfolio systems. The lead will also work closely with these stakeholders to implement process changes and drive adoption.

 support organizational growth.
